**(B) Estimated date of completion of development**  
項目預計完工日期

Pursuant to the Authorized Person's Certificate dated 26<sup>th</sup> May 2010, the estimated date of completion of the development in accordance with clause 4(1)(c) of the Agreement for Sale and Purchase (ASP) is on or before 25<sup>th</sup> November, 2011 subject to such extensions of time as may be granted by the Authorized Person in accordance with clause 4(5)(a) of the ASP. The issue by the Director of Lands of a certificate of compliance (CC) or consent to assign (CA) is conclusive evidence that the development has been completed or is deemed to be completed as the case may be and nothing herein shall preclude the Developer from proving that it has completed the development in accordance with clause 4(1)(c) of the ASP by any other means. The Developer shall notify the purchasers in writing that it is in a position validly to assign the Units within one month of the issue of the CC or the CA, whichever is the earlier and the sale and purchase of the Units shall be completed within 14 days of the date of the Developer's written notification to the purchasers.

根據認可人士於 2010 年 5 月 26 日簽發的證書，本發展項目按買賣合約第 4(1)(c)條款完成的預計完工日期為 2011 年 11 月 25 日或以前，但認可人士可根據買賣合約第 4(5)(a)條款批准延伸該預計完工日期。地政總署署長因應實際情況發出的滿意紙或轉讓同意書，是不可推翻的證據，證明該發展項目已完成或視為完成。但這並不限制發展商透過其他方法，證明已按買賣合約第 4(1)(c)條款完成該發展項目。發展商須於滿意紙或轉讓同意書發出後一個月內（以較先者為準），以書面通知買方他有權轉讓物業。買賣交易須於發展商書面通知買方後十四天內完成。
